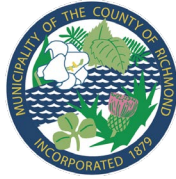

Motion carried.

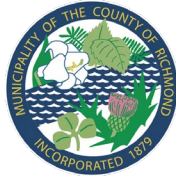
Business Arising from the Minutes
