**MUNICIPALITY OF RICHMOND COUNTY
BYLAW NUMBER 58
REPEALS BY-LAW**

BE IT ENACTED by the Council of the Municipality of the County of Richmond, pursuant to the *Municipal Government Act*, S.N.S. 1998, c.18, as amended, as follows:


