

**COMMITTEE OF THE WHOLE REPORT**  
**FOR THE MONTH OF JANUARY, 2015**

The Committee has met once since the last Council Meeting.

The Committee reviewed the property of Anja Sampson and Vonnie Carter.

**I move that Council accept the recommendation of the Committee of the Whole and that an “Order to Remedy Condition” be issued to Anja Sampson and Vonnie Carter, 8718 Highway 4, River Bourgeois, NS (PID #75105981, AAN# 04736184) and that the Order be a Demolition Order issued from Council to the owners. The Order should state to the owners that the buildings are to be demolished and all debris be removed and disposed of in the appropriate manner within ninety (90) days. If the property owner fails to comply, the Municipality will complete the same and recover the costs.**

The Committee reviewed Heavy Garbage.

**I move that Council accept the recommendation of the Committee of the Whole and that Heavy Garbage Pickup be tendered for a period of one (1) year, based on the criteria outlined by the Public Works Director, and that it take place in June.**

The Committee reviewed the Property of Pauline Walsh.

**I move that Council accept the recommendation of the Committee of the Whole and that an “Order to Remedy Condition” be issued to Pauline Walsh, 8338 Highway 4, River Bourgeois, NS (PID #75045526, AAN# 00549762) and that the Order be a Demolition Order issued from Council to the owners instructing that the dwelling unit be demolished and all debris be removed from the property within thirty (30) days or the Municipality will complete the same and recover the costs through property taxes.**

The Committee reviewed a Borrowing Resolution/Loan Guarantee request from the St. Peter’s & District Volunteer Fire Department.

**I move that Council accept the recommendation of the Committee of the Whole and the Director of Finance and that a borrowing resolution and loan guarantee in the amount of \$300,000 for the St. Peter’s & District Volunteer Fire Department, conditional on the necessary paperwork being provided by the department, be approved.**

The Committee reviewed Fire Protection Services for Point Tupper.

**I move that Council accept the recommendation of the Committee of the Whole and that that the Fire Protection Agreement with the Town of Port Hawkesbury end on March 31, 2015 and that the Louisdale Volunteer Fire Department and West Bay Road Volunteer Fire Department be named first responders for calls to the Point Tupper area.**

The Committee reviewed grant requests.

**I move that Council accept the recommendation of the Committee of the Whole and that the following grants be approved:**

- **\$300 to St. Hyacinth Parish, Municipal District Activity Fund, District #3;**
- **\$1,500 to St. Joseph's Parish, Municipal District Infrastructure Fund, District #2;**
- **\$920.23 to South Mountain Arm of Gold Association, Municipal District Activity Fund, Multiple Districts;**
- **\$700 to St. Peter's Scottish Country Dancers, Municipal District Activity Fund, Multiple Districts.**
