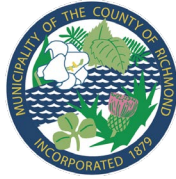

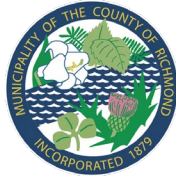
### **Election of Vice Chair**
