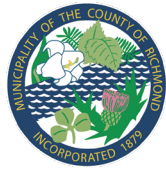

Councillor Shawn Samson called the meeting to order at 6:03 p.m.

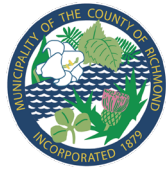
2. **Items Added to the Agenda**

Sgt. Brad Kelly reviewed the Policing Report from October to November 2025.

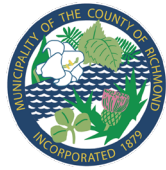
Moved by Councillor Brent Sampson, seconded by appointed member Stacey Morrison, that the Board accept the Policing Report.
